**OPEN COMPETITION
FOR THE ARCHITECTURAL CONCEPT DESIGN OF SOCIAL HOUSING IN CACAK**

The aim of the competition is to provide optimal innovative site layout for the new housing complex in Kosutnjak settlement in Cacak and architectural solutions for 76 social housing apartments, thus contributing to the promotion of rational designing in the housing sector, paying particular attention to functionality, economy of construction, rational use of land, costs of construction and maintenance, protection of the environment and special needs of beneficiaries.

The competition is announced in accordance with the Regulations of the Association of Architects on Competitions in the field of Architecture and Urbanism. All legal entities and individuals with appropriate professional qualifications and students of architecture from the territory of Serbia and Montenegro who have officially obtained the original competition documentation are entitled to participate in the competition.

Upon presenting evidence of payment of 600,00 dinars to the account of the Municipal Housing Agency Cacak, number 840-371647-08, with an indication "payment for the architectural concept design", competition applicants may obtain the competition documentation in the offices of the Municipal Housing Agency Cacak, Zupana Stracimira 2, first floor of the Building of Cacak Municipality every working day from 8.00 to 14.00, and in the offices of the Association of Architects of Serbia, Kneza Milosa 7/3, Belgrade, every working day from 9.00 to 14.00.

The entries will be examined by the Jury composed by:

- Svetlana Ristić, representative of the Ministry for Capital Investments,
- Representative of the Association of Architects of Serbia,
- Danka Jovanović, representative of the Department of Urbanism of Cacak Municipality
- Brankica Jelic, representative of the Municipal Housing Agency Cacak,
- Representative of UN-HABITAT, SIRP office

The Jury will select, rank and give awards, the awarded prizes being:

<i>First prize</i>	120,000.00 dinars
<i>Second prize</i>	50,000.00 dinars
<i>Third prize</i>	30,000.00 dinars

The competition will start on Tuesday 25 April 2006, and will be finished on Monday 29 May 2006 at 14,00 and entries should be submitted in the office of "Municipal Housing Agency" Zupana Stracimira 2, or in the offices of the Association of Architects of Serbia, Kneza Milosa 7/3, Belgrade.
